Front Side of Zoning Ballot

ARE YOU IN FAVOR OF AMENDMENT (#) AS PROPOSED BY THE PLANNING BOARD FOR THE TOWN OF HOLLIS ZONING ORDINANCE AS FOLLOWS:

AMENDMENT (1) Description: Removal of drainage restrictions from zoning ordinance

Explanation: This amendment removes key wetlands protections from our ordinance. It simplifies the process of getting an exemption from stormwater restrictions, which favors developers.

Recommendation: Vote NO

AMENDMENT (2) Description: Requirement that developers submit notice of site development to Planning Board

Explanation: This amendment will require developers to notify the Town prior to conducting site development work. It provides for enforcement actions as well.

Recommendation: Vote YES

AMENDMENT (3) Description: Restoration of the ability to store propane underground in the Aquifer Zone

Explanation: This amendment restores residents' ability to have propane tanks installed underground, which had been the practice in Hollis for many years.

Recommendation: Vote YES

AMENDMENT (4) Description: Prohibition on manned aircraft landing and takeoff

Explanation: This amendment prohibits manned aircraft landing and takeoff in Hollis, including hot air balloon takeoff and landing. HollisWatch does not take a position. More info online at HollisWatch.com

Recommendation: Hollis Watch does not take a position.

Back Side of Zoning Ballot

AMENDMENT (5) Description: Limitation of construction noise for developments of three or more units

Explanation: This amendment imposes restrictions on construction noise, which would only be permitted from 8:30 a.m. to 5:30 p.m. Monday through Friday.

Recommendation: Vote YES

AMENDMENT (6) Description: Clarification of definitions to be more restrictive of high-density development

Explanation: This amendment clarifies definitions. It is more restrictive relative to the development of high-density housing.

Recommendation: Vote YES

HollisWatch recommends that residents **do not** vote for Bill Moseley for Select Board; he consistently allows developers' assertions to go unchallenged in his role as Planning Board Chair. HollisWatch does not take a position on the other candidates.
